- Candidate should not be less than 18 years and not more than 32 years in age as on 01.01.2025 as per Office Memorandum No.PER.38/2021/30 dated 03.02.2022. Upper age limit is relaxable by 5 (five) years in case of SC/ST candidates.
- The date of birth to be accepted is as entered in the Birth Certificate issued by Competent Authority or Matriculation/Secondary School Leaving Certificate. Proof other than these will not be accepted
- PWDs candidates upper age limit will be as per Office Memorandum No. PER (AR)150/88/560, Dated Shillong, the 18<sup>th</sup> January,2023.

#### 4. PROBATIONARY PERIOD:
